Year 2 Application Instructions

For students entering the 8th or 9th grade

Come to AIS PREP to discover, learn, grow, make new friends, prepare for high school, experience college life, and explore possible careers.

WHAT IS AIS PREP?

AIS PREP is a mathematics-based, academic enrichment program that emphasizes the development of abstract reasoning and problem solving skills. AIS PREP helps students prepare for careers in the fields of Science, Technology, Mathematics, and Engineering. The program includes course work, homework, hands-on experiments, and field trips.

AIS PREP YEAR 2 COURSES

- **Algebraic Structures**
- **Introduction to Physics**
- **Problem Solving II**
- **Research and Study**
- **Strong Teens** is a practical social-emotional learning program designed for teaching emotional skills, promoting resilience, strengthening assets, and increasing coping skills of students aged 12-18. Subjects of the program include: emotional strength, understanding your and others feelings, dealing with anger, and letting go of stress.

AIS PREP DETAILS

- **Class hours:** 8:50 am – 3:00 pm, Monday through Friday beginning June 26th—August 4th. Field trips are on Fridays. Evening supplemental activities/classes from 6:00pm – 9:30pm. Lights out at 10:00pm.
- **Location:** Utah State University (Blanding campus)
- **Cost:** There is no enrollment fee. Students will be provided transportation from designated locations, housing and meals.

REQUIREMENTS

Participant must:

- Currently be enrolled in the 7th or 8th grade.
- Fill out the application materials (see “Application Checklist”) by the Jan 31, 2017 deadline.
- Have an 80% or better in mathematics class.
- Be in good standing in all courses.
- Attend all 6 weeks of AIS PREP. Only THREE **excused** absences are allowed before dismissal from the program (see “Frequently Asked Questions” for more detailed information regarding absences).
- Live in on-campus housing Mon – Fri, provided by AIS PREP program at no expense to student.
- Complete **daily** homework assignments. Three missed homework assignments will result in the student missing a Friday field trip and being put on probation until a parent meeting has taken place.

Checklist for Completing the Application

- Fill out all application Questions regarding:
 - Student Personal Information
 - Parent/Guardian Information
 - Photo release form
- Typed or *legibly* hand-written 100-200 word essay in ink (preferably black) in response to the question “Why do you want to attend AIS PREP?”
- The AIS PREP Application requires a nomination from one of the student’s teachers. A survey has been attached to this packet; the teacher is to fill it out and return it to the student in an envelope or scan and email it to prep@americanindianservices.org. The teacher will fill out information regarding the student’s academic performance, conduct in class, maturity, punctuality, etc.
- Turn in a copy of your most recent report card
 - Must list the school district and school information
 - Contact AIS if you attend a private school or are home schooled
 - Must include a conduct/citizenship grade
 - If you have lost your report card, ask your school counselor for a duplicate on school letterhead
- All paperwork must be postmarked on or before January 31st, 2017. *Don't miss it!* LATE APPLICATIONS WILL NOT BE ACCEPTED.
- Either return you application to your local AIS representative or mail your completed application packet which includes: Student Personal Information page, Parent/Guardian Information page, essay, and a copy of your most recent report card to:
